This privacy policy sets out how Red Dot Europe uses and protects any information that you provide us when you use our company, we strongly recommend you read the full policy.

Should we ask you to provide certain information by which you can be identified when using our company and the services / products we offer, then you can be assured that it will only be used in accordance with this privacy statement.

We may change this policy from time to time by updating this document.

### **Why we collect your information**

We may obtain, use, process and disclose personal data to:

- provide you with professional services
- undertake quality, security and risk management activities
- provide you with information about us and our services
- develop our business and services
- comply with legal, regulatory or professional body requirements

### **What information we collect**

We may collect the following information:

- full name, company name, job title, contact and personal details including email address
- business activities
- demographic information such as postcode, preferences and interests
- other information relevant to customer surveys and/or marketing offers

### **What we do with the information we gather**

We require this information to understand your needs and provide you with a better service, and in particular for the following reasons:

### **Security and storage of personal data**

We retain personal data for as long as we consider it necessary for the purpose for which it was collected including as required by law or regulation. As a general rule we will retain data for 7 years. In the absence of specific legal, regulatory or contractual requirements we will delete data 7 years after we cease to have dealings with the contact. Some data is deleted sooner.

### **Security**

We are committed to ensuring that your information is secure. In order to prevent unauthorised access or disclosure, we have put in place suitable physical, electronic and managerial procedures to safeguard and secure the information we collect online.

Our website hosting is provided by a company with servers in the United Kingdom.

When information is transferred to countries outside the EU (some of our internal systems are supported by servers based at our headquarters in Seattle, USA) strict security and safety precautions are in place to ensure the safety of your data – such as our internal secure MPLS private lease line.

**How we use cookies**

A cookie is a small file which asks permission to be placed on your computer's hard drive. Once you agree, the file is added, and the cookie helps analyse web traffic or lets you know when you visit a particular site. Cookies allow web applications to respond to you as an individual. The web application can tailor its operations to your needs, likes and dislikes by gathering and remembering information about your preferences.
